### **INTERNATIONAL STUDENT - TWO STEP REGISTRATION AND VISA PROCESS**

#### **STEP 1 - OBTAINING I-20 FOR VISA PROCESSING**

1. Complete the 'Student Agreement', 'International Student Registration Form' and 'Accommodation and Transportation Agreement' and return to us for processing. You can also download these forms at [www.visionflighttraining.com](http://www.visionflighttraining.com) (Acrobat 7.0 or later required).
2. Provide a photocopy (preferably color) of your passport - passport must be valid for a minimum of one year.
3. Make a payment in the amount of US\$ 300.00 (or equivalent in Indian Rupees in cash) as enrollment and processing fee.

**On completion of the above steps we will issue the I-20 form for M1 visa processing.**

**We will also issue the documents listed below to the student for obtaining a letter of commitment from a bank for an education loan for flight training. This bank letter can also be used for visa process as proof of financial viability.**

- 1) Letter of admission for flight training.
- 2) Certificate verifying Vision Flight Training Inc. as representative of flight school.
- 3) 'Air Agency Certificate' (FAA certification) for flight school.

You can obtain a letter from a bank based on your existing funds at a bank or obtain an education loan. **In most cases banks request documents listed above to issue education loans.** Below is a sample format of a bank letter that you should request for showing at your visa interview if required.

#### **TO WHOM IT MAY CONCERN**

This letter is being furnished on behalf of (Name as it appears in Passport) r/o (Address as it appears in Passport). He has applied for Professional Pilot Training with your institution Dean International located in Miami, Florida, USA.

(Bank Name) hereby certifies that it has agreed in principle to sanction education loan for the aforementioned training in the amount of Rupees 18 lacs. This loan will be disbursed subject to final approval of admission for training and furnishing of proof of visa availability by the applicant for flight training at your flight school.

#### **STEP 2 – OBTAINING A VISA FROM THE US EMBASSY/CONSULATE (read SEVIS, TSA and visa information section carefully):**

1. **Before applying for visa** - Register with SEVIS and file the I-901 fee. This is a one-time fee for International students coming to USA for education (**fee is the responsibility of the applicant**).
2. OBTAIN YOUR M1 VISA from the embassy/consulate nearest to you (**visa fee is the responsibility of the applicant**).
3. Register with TSA. **TSA is not required for visa**. However, TSA clearance is required for all flight training in USA. Follow the steps described in the 'SEVIS, TSA and VISA INFORMATION' section of this package.
